








RULES AND REGULATIONS

Event Spaces: We offer over 6,000 sq. ft. of interior meeting space as well as 3 outdoor venues, including the Lazy River Deck that overlooks the picturesque Gulf coastline, the beautifully manicured grassy Breezeway that sits on the bay, and the stunning Bravo Outdoor Pool Lawn.

Charges: Facility rental fee includes the use of the facility, set-up and break-down of tables, chairs, and linens. A \$500 security deposit is required to reserve the event space. A second payment of 50% of the balance is due six months prior to the event date. Payment of the remaining balance of the rental fee is due sixty (60) days in advance of the event.

Event Space Requirements: All decorations must be approved in advance by Caribe Resort's Event Coordinator and must be removed by 12PM on the night of your event (unless otherwise stated in contract) or they will be discarded.

Event Schedule: For all events being held outdoors a backup decision will be made 24 hours in advance. Should the rain forecast exceed 30% or wind speed exceed 15 knots, the backup space will be utilized. Caribe Resort Management will have the final decision.

Entertainment: All entertainment must conclude at 10PM in order to comply with the city and resort noise ordinances. Caribe Resort reserves the right to stop entertainment at any time during the event if there are complaints of any nature (too loud, offensive language, etc.).

Catering: All food and beverage catering will be sold by Alabama Coastal Catering. No food and beverage items other than a wedding cake may be brought in.

Rental Units: All functions booked at Caribe Resort must use Caribe Realty rental units. Please consult with Caribe's Event and Group Sales Coordinator for minimum night requirements of rental units. Units booked through an outside agency, or any private rentals do not count toward the minimum number of units required. You must be 25 years old to rent the event space or any condominiums. Rates and policies are subject to change without notice.

Cancellations: Please notify Caribe Resort immediately in writing or by email. Once cancelled, the Customer shall be responsible for agreed liquidated damages.

Responsibility/Liability: In renting the event space you are assuming all risk of liability for any damages done to the property or person, agents, employees or visitors occasioned by the present or future condition of the premises both latent and manifest. Caribe Realty, The Caribe Homeowners Association, or the Developer, will not be responsible for accidents, injury to guests, lost money or valuables of any kind. Your responsibilities include leaving the event space in its regular state, which includes returning items to their proper place. Deposits are forfeited for any additional cleaning or space that is left in up-proper order.

No Pets/No Smoking: No pets and no smoking are allowed anywhere on property, inside or outside.

No Glass/No Open Flame/No Grass Stakes: No Glassware is allowed on the lazy river deck or any of the pool areas indoor or outdoor. No Sparklers or tiki torches are allowed anywhere on property. Nothing shall be stuck into the ground.

Management: We reserve the right to refund deposits, refuse rental, or to discontinue rental if in our judgement your rental of the event space is determined to the property. We also reserve the right to inspect the rental space at any time. Property may not be used for unlawful purposes.

Event Services and Goods Provided: Caribe Resort will provide tables, chairs, linens, and trash services. Caribe Resort will be responsible for the set-up and break-down of all tables, chairs, and linens. All Lazy River Deck events are required to rent five cabanas for the day of the event. Cabana rentals are discounted to \$150-\$250 per cabana. Customer serves the right to access cabanas and venues from 9AM-11PM the day of event.

Parking: All guests will receive complimentary event parking passes from the guard shack upon arrival.

Transportation: Caribe Resort provides onsite transportation in the form of trolleys for onsite travel only. Trolley pick-up and drop-off locations include lower parking deck in building C and D, upper parking deck in building B, Florida Point- Gulf State Park, Cobalt the Restaurant, and Caribe Marina. Trolleys run on an on-call basis (unless stated otherwise in contract).
